DESCRIPTION: REVIEW AND EXTENSION OF DANNHAUSER LAND USE MANAGEMENT SCHEME

Dannhauser Municipality hereby invites suitable service providers to tender for Contract No.19/08/2020 for Review and Extension of a Single Land Use Management Scheme for Dannhauser Municipality.

A **NON-REFUNDABLE BID** document fee of **R250.00** is payable at the cashier's office from **24/08/2020** during office hours at 07h30 to 15h00 with a lunch interval of 13h00 to 13h30, at 08 Church Street, Dannhauser Municipality.

This bid will be evaluated in terms of the 80/20 preferential point system as prescribed in the Preferential Procurement policy Framework Act (No 5 of 2000 Amended in 2017). Original Certified BBBEE certificate must be submitted.

In terms of section 13 of the Municipal Supply Chain Management Policy and the official tender procedures, the Municipality will reject all tenders that do not comply with the following conditions:

- Bidders must be registered on the Central Supplier Database and proof of registration must be submitted.
- Price(s) quoted must be valid for at least ninety (90) days after the bid closing date.
- Price(s) quoted must be firm and inclusive of VAT
- Bidders must include both Tax Clearance Certificate and SARS Pin.
- This bid is subject to the general conditions of contract (GCC) and if applicable, any other specific conditions of contract.
- Bidders must complete all MBD Forms.
- Detailed breakdown of fees and No hidden cost will be considered.
- Company profile with traceable references.
- CIPC Registration certificate "CK"
- Current municipal rates account.
- Capacity to undertake work within stipulated time frame.
- Background and experience of the firm in a related field.
- Must be registered with SACPLAN as a Professional Planner.
- Provision of a Zulu speaking person for translation and public participation purposes.
- No bids will be considered from persons in the service of the state.
- Bidders must fill in the tender register stating the date and time of when they submitted their tender, available at the tender box.
- The Municipality reserves the right to withdraw any invitation to tenders and/or to re-advertise or to reject any tender or to accept a part of it.
- The Municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points
- Dannhauser remains at liberty to separate phases at the level of evaluation, adjudication and appointment.
- All material, local labour (skilled and unskilled), plant and equipment of which the appointed contractor does not have must be sourced locally.
