68×90×73×90 metres total 321m.

4 corner poles with 2 stays for each pole to withstand pull.

Corner poles should be of white treated wood thickness minimum = 150mm.

Corner poles should be 12 metre above ground concreted 1 metre below ground. Galvanised double strand barbed wire 6 rows. (Sample should be supplied to municipality) Standards should be 3 m equally apart 1, 5 above ground and 300m underground.

Centre stays poles (150 mm wide) should be 50 metres apart with 2 stays on either side. Centre poles should be able to withstand pull strain and concreted 1/2m in the ground. Droppers should be 1 m apart.

1× single meter gate to be supplied and installed and well fitted.

The six strands of barbed wire height to be equally spaced.

The standards and dropper to secured to the strands of barbed wire with bailing wire, Fencing should be completed within 15 working days from date of appointment.
