Dannhauser Municipality hereby invites the suitable service providers to tender for tender No. 14/04/2021 for supply and delivery of toilet material for a period of 36 months

GENERAL DESCRIPTION

- 1 X 3 toilet rooms Air freshener dispense SH (2 monthly)
- 1 X 3 toilet rooms Air towel Lambrianos S/S
- 1 X 3 toilet rooms Paper Towel Cabinet
- Paper Towel 1 ply for 3 toilet rooms (15 per month)
- 1 X 2 toilet rooms She Bin Pedal Intima White (to be changed every fortnight)
- 1 X 4 toilet rooms Wipe Dispensers Freshands Flats pack white
- 16 X Wipe Care Toilet Seat Perforated 200 (100 per pack) for 4 toilets (per month)

This bid will be evaluated in terms of the 80/20 preferential point system as prescribed in the Preferential Procurement Policy Framework Act (No 5 of 2000). Original certified BBBEE must be submitted.

In terms of section 13 of the municipal Supply Chain Management Policy and the official tender procedures, the Municipality will reject all tenders that do not comply with the following conditions.

Conditions

- Bidders must be registered on the Central Supplier Database and proof of registration must be submitted
- Price(s) quoted must be valid for at least ninety (90) days after the bid closing date.
- Price(s) quoted must be firm and inclusive of VAT
- Delivery cost to must be included on the total price.
- Bidders must include Tax Clearance Certificate (SARS Pin)
- This bid is subject to the general conditions of contract (GCC) and if applicable, any other specific conditions of contract.
- MBD 4, MBD 6, MBD 8, and MBD 9 must be scrutinize, completed and submitted together with the proposal; forms are available from the website and from the SCM unit (**available on our website www.dannhauser.gov.za under budget**) CIPC Registration certificate "CK"
- Current municipal rates account or proof of residence for those who reside in rural areas
- No bids will be considered from persons in the service of the state.
- Bidders must fill in the Tender register stating the date and time of when they submitted their tender documents, available at the tender box.
- The Municipality reserves the right to withdraw any invitation to tenders and/or to re-advertise or to reject any tender.
- The Municipality does not bind itself to accepting the lowest tender or award a contract to the bidder scoring the highest number of points.

EVALUATION CRITERIA

Only bidders who quoted correctly and according to the Specifications/ General description will be considered for the final stage which is Pricing (80/20).

Tenders must be submitted in a sealed envelope; clearly marked "**TENDER NO: 14/04/2021 SUPPLY AND DELIVERY OF TOILET MATERIAL FOR A PERIOD OF 36 MONTHS**" and must be deposited into the tender box situated at the reception area of Dannhauser Municipal offices.
