SCOPE OF WORK:

SUBJECT : Requisition for Manufacturing and Installation of Signage at New Municipal Offices (1 West Street)

Purpose

This memo serves to request the initiation of the procurement process for the manufacturing and installation of signage at the new municipal premises located at 1 West Street, Dannhauser, in line with the approved Branding and Communication Plan.

Background

The municipality is relocating its offices from 8 Church Street to 1 West Street. As part of this strategic move, internal and external signage must be installed to ensure:

- Enhanced visibility and brand consistency
- Clear wayfinding for visitors and staff
- Positive first impressions and public confidence

The signage is a critical component of the rebranding effort and should reflect the municipality's commitment to professionalism, excellence, and service delivery.

Scope of Work

1. External Signage

• Main Building Signage:

- Location: Above main entrance and facing West Street
- o Material: Durable, weather-resistant aluminum or equivalent
- Features: Illuminated with LED backlighting; includes municipal logo and full name

• Directional Signage:

- Placement: Along key approach routes to 1 West Street
- Material: Metal or composite board with UV-resistant coating

• Temporary Signage at 8 Church Street:

- Content: Notice of relocation, inset map to new premises
- Placement: Main gate, reception, and library
