## SUBJECT: Requisition for Manufacturing and Installation of Signage at New Municipal Offices (1 West Street)

### **Purpose**

This memo serves to request the initiation of the procurement process for the manufacturing and installation of signage at the new municipal premises located at 1 West Street, Dannhauser, in line with the approved Branding and Communication Plan.

### **Background**

The municipality is relocating its offices from 8 Church Street to 1 West Street. As part of this strategic move, internal and external signage must be installed to ensure:

- Enhanced visibility and brand consistency
- · Clear wayfinding for visitors and staff
- Positive first impressions and public confidence

The signage is a critical component of the rebranding effort and should reflect the municipality's commitment to professionalism, excellence, and service delivery.

### **Scope of Work**

### 1. External Signage

- Main Building Signage:
  - Location: Above main entrance and facing West Street
  - o Material: Durable, weather-resistant aluminum or equivalent
  - Features: Illuminated with LED backlighting; includes municipal logo and full name

### Directional Signage:

- Placement: Along key approach routes to 1 West Street
- Material: Metal or composite board with UV-resistant coating

### Temporary Signage at 8 Church Street:

- Content: Notice of relocation, inset map to new premises
- Placement: Main gate, reception, and library
- Duration: Must be durable enough to remain intact and legible for a minimum of Six (6) months

### 2. Internal Signage

### Reception Area:

- Material: Brushed aluminium letters with backlighting
- Content: Municipal logo and the tagline "Serving Delivery Excellence" or equivalent
- Placement: Centered behind the main reception desk

### Office Door Signs:

- Material: Acrylic with frosted or clear finish, aluminium option for executive offices
- Content: Title, and department
- Size: Standardised across all offices for uniformity

Placement: Mounted at eye level on or beside the office door

### Departmental Signage:

- o Material: Acrylic or aluminium
- Content: Department name with relevant icon (e.g., Finance, HR, Technical Services)
- Placement: Above department entrances and office doors

### Wall Branding/Murals:

- Location: Key communal areas hallways, meeting rooms, and break areas
- Design: Vinyl wall graphics or framed prints with mission statement, values, and community imagery
- Size: To be determined during site inspection

### Flags and Emblems:

- o Exterior: Flagpoles with municipal flags and other
- Interior: Mounted flags in reception and council chambers

- 1.3 Points for this quotation (even in the case of a tender for income-generating contracts) shall be awarded for:
  - (a) Price; and
  - (b) Specific Goals.

### 1.4 To be completed by the organ of state:

The maximum points for this tender are allocated as follows:

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

### 2. **DEFINITIONS**

- (a) "tender" means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) "price" means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) "rand value" means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) "tender for income-generating contracts" means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
- (e) "the Act" means the Preferential Procurement Policy Framework Act, 2000 (Act No. 5 of 2000).

### 3. FORMULAE FOR PROCUREMENT OF GOODS AND SERVICES

### 3.1. POINTS AWARDED FOR PRICE

#### 3.1.1 THE 80/20 PREFERENCE POINT SYSTEMS

A maximum of 80 points is allocated for price on the following basis:

### 4. POINTS AWARDED FOR SPECIFIC GOALS

- 4.1. In terms of Regulation 4(2); 5(2); 6(2) and 7(2) of the Preferential Procurement Regulations, preference points must be awarded for specific goals stated in the tender. For the purposes of this tender the tenderer will be allocated points based on the goals stated in table 1 below as may be supported by proof/ documentation stated in the conditions of this tender:
- 4.2. In cases where organs of state intend to use Regulation 3(2) of the Regulations, which states that, if it is unclear whether the 80/20 or 90/10 preference point system applies, an organ of state must, in the tender documents, stipulate in the case of—
  - (a) an invitation for tender for income-generating contracts, that either the 80/20 or 90/10 preference point system will apply and that the highest acceptable tender will be used to determine the applicable preference point system; or
