1. PURPOSE

The purpose of this Request for Quotation (RFQ) is to invite registered Tax Practitioners to submit a quotation for the provision of lump sum tax recalculation and opinions/ guidance in respect of over/ under payment of Pay-As-You-Earn (PAYE) and other areas of taxes within the Finance and Human Resource Office.

2. SCOPE OF WORK

The appointed tax practitioner will assist Dannhauser Local Municipality (DLM) with the performance of the following, amongst others, that are not listed:

- Tax Calculations: Tax Practitioner must assist to ensure that tax calculations for councilors gratuity / lumpsum payments are correct.
- interact with SARS on resolving employee tax issues for which DLM does not have the necessary expertise.
- Handle technical tax issues.
- Updates and Changes: The Tax Practitioner must remain up to date with relevant changes to tax laws and regulations and communicate such changes to relevant staff.
- Reporting: The Tax Practitioner must provide written tax opinion on any issues identified during the implementation of the project.

3. MANDATORY TECHNICAL REQUIREMENTS

- 1.5 Failure on the part of a tenderer to submit proof or documentation required in terms of this tender to claim points for specific goals with the tender, will be interpreted to mean that preference points for specific goals are not claimed.
- 1.6 The organ of state reserves the right to require of a tenderer, either before a tender is adjudicated or at any time subsequently, to substantiate any claim in regard to preferences, in any manner required by the organ of state.

2. DEFINITIONS

- (a) **“tender”** means a written offer in the form determined by an organ of state in response to an invitation to provide goods or services through price quotations, competitive tendering process or any other method envisaged in legislation;
- (b) **“price”** means an amount of money tendered for goods or services, and includes all applicable taxes less all unconditional discounts;
- (c) **“rand value”** means the total estimated value of a contract in Rand, calculated at the time of bid invitation, and includes all applicable taxes;
- (d) **“tender for income-generating contracts”** means a written offer in the form determined by an organ of state in response to an invitation for the origination of income-generating contracts through any method envisaged in legislation that will result in a legal agreement between the organ of state and a third party that produces revenue for the organ of state, and includes, but is not limited to, leasing and disposal of assets and concession contracts, excluding direct sales and disposal of assets through public auctions; and
