TERMS OF REFERENCE FOR THE APPOINTMENT OF SERVICE PROVIDER TO PROCURE EQUIPMENT IN SUPPORT OF SMMES FOR PERIOD OF THREE YEARS.

1. Background

The Dannhauser Local Municipality, through the department of planning under Local Economic Development (LED) unit wishes to implement a Municipal Employment Initiative (MEI) to support local SMMES through funding for essential equipment. The aim of this initiative is to align the functionality of LED with its core mandate of stimulating local economy by supporting growth and development of SMMES. The municipality is seeking to appoint reputable and experienced service providers to procure and deliver equipment to approved SMMES.

2. Objectives
