SCOPE OF WORK

SUPPLY WITH K53 YARD TEST OBSTACLE POLE AND STANDS X38

1. Purpose

The purpose of this request for the procurement of K53 yard test obstacle poles and stands required for the proper execution of driver licence testing within the Traffic department.

2. Background

The Traffic Department is mandated to conduct K53 learner and driver licence tests in accordance with the standards prescribed by the Road Traffic Management Corporation (RTMC).

Currently, the obstacle poles and stands used in the yard test are either damaged, missing, or no longer compliant with testing standards. This has resulted in challenges during testing sessions and poses a risk to the integrity and fairness of the testing process.

The procurement of new K53-compliant obstacle poles and stands will ensure that the yard test area meets regulatory requirements and continues to operate efficiently and safely.

- 1 This Municipal Bidding Document (MBD) must form part of all bids¹ invited.
