**NOTICE IN TERMS OF SECTION 116(3) OF THE LOCAL GOVERNMENT: MUNICIPAL FINANCE MANAGEMENT ACT, 2003 (ACT 56 OF 2003) FOR THE AMENDMENT OF THE EXISTING FINANCIAL MANAGEMENT SYSTEM – MUNSOFT FOR A PERIOD OF THREE YEARS**

Notice is hereby given in terms of Section 116 (3) (a) and (b) of the Local Government: Municipal Finance Management Act, 2003 (Act 56 of 2003) that the Dannhauser Local Municipality intends to amend the existing contract.

**Description: Amendment of Scope for Construction of 15 x Disaster Houses  
2025/26**

**Service Provider: Dikidi Group**

**Tender No. REF: NO.6/1/2/2: Turnkey**

**Reasons for the proposed Extension of Scope:** In terms of MFMA Circular No 62 of the National Treasury, accounting officers of municipalities are advised that contracts may be expanded or varied by not more than 20% for construction-related, and/or infrastructure projects, 15% for goods and/or services of the original value of the contract. Anything beyond the abovementioned thresholds must be reported to the council, and any expansion or variation in excess of the threshold must be dealt with in terms of the provisions of section 116(3) of the MFMA, which will be regarded as an amendment to the contract.

The adjustment of scope exceeds 20% from the initial appointment of the Service provider for additional 15 units to be constructed for 2025/26 financial year.

Notice is hereby further given in terms of Section 21 and 21A of the Local Government: Municipal Systems Act, 2000 (Act 32 of 2000) that the local community and interested/affected parties are invited to submit comments or representations to the Municipality in respect of the above, such comments or representations must be received within **14 days of advertisement notice i.e. from 27 November 2025 to 12 December 2025 at 12H00 p.m.** via electronic mail to the e-mail address provided below, or be delivered to the undersigned to the mailing address provided hereunder.


